#### **Board of Zoning Appeals Activities:**

- July 26, 2018 BZA Meeting: Canceled
- August 23, 2018 BZA Meeting:
  - BZA05-2018: E.E. Wood Homes LLC is requesting an area/dimensional variance to allow for an existing 0.507 acre non-conforming lot in the E District containing a newly constructed two-family dwelling to be split to allow for each unit to be sold separate and apart from the other, one unit would be on a new lot containing 0.313 acres, the other would be on a new lot containing 0.194 acres. A 0' side yard setback is proposed (the lot is proposed to be split down the center of the shared wall of the two-family structure). The subject property is 4357 and 4359 Edelweiss Drive, parcel L32000100040003300, owned by E.E. Wood Homes LLC, containing 0.507 acres, and located in the E (Rural Estate Residential) District.
  - BZA06-2018: Icon Solar is requesting an area/dimensional variance to allow for a solar array to be mounted on the roof of an existing accessory structure located in the side yard of the subject property. Solar arrays are permitted to be mounted on the roof of an accessory structure, but only an accessory structure located in the rear yard. The subject property is 735 Shepherd Road, parcel L32000200300011000, owned by David S. and Susan Troeter, containing 6.516 acres, and located in the A-1 (Agricultural) District.

Oberer Land Developers, LTD is also requesting preliminary development plan approval under Article 6 of the Sugarcreek Township Zoning Resolution for approval of the preliminary plan for a proposed subdivision.
